Treść raportu:

Management Committee of Automotive Components Europe S.A. hereby informs that on 22 June 2010 the Company received an official notification from ING Towarzystwo Funduszy Inwestycyjnych SA, acting on behalf of managed portfolio of investment funds (hereinafter referred to as "the Funds") that due to the purchase transaction of Automotive Components Europe SA (hereinafter referred to as "the Company") shares by ING Specjalistyczny Fundusz Inwestycyjny Otwarty Akcji 2 that took place on 18 June 2010 the total number of the Company's shares owned by the Funds increased and the threshold of 5% of total number of votes in the Company was exceeded.

In result of the abovementioned transaction the Funds hold 1 087 615 Company's shares consisting of 5.12% of the Company's share capital and entitling to 1 087 615 votes that correspond to 5.12% of the total votes in the Company.

Before the abovementioned transaction the Funds held 1 048 071 Company's shares consisting of 4.94% of the Company's share capital and entitling to 1 048 071 votes which correspond to 4.94% of the total votes in the Company.

Zarząd Automotive Components Europe S.A. niniejszym informuje, że w dniu 22 czerwca 2010 roku wpłynęło do Spółki oficjalne zawiadomienie od ING Towarzystwa Funduszy Inwestycyjnych SA, działającego w imieniu i na rzecz zarządzanych funduszy inwestycyjnych (dalej "Fundusze"), że w wyniku transakcji kupna akcji spółki Automotive Components Europe SA (dalej "Spółka") przez ING Specjalistyczny Fundusz Inwestycyjny Otwarty Akcji 2 dokonanej w dniu 18 czerwca 2010r, poziom zaangażowania Funduszy w ogólnej liczbie głosów na walnym zgromadzeniu Spółki przekroczył próg 5%.

W konsekwencji ww. zdarzenia Fundusze posiadają 1 087 615 sztuk akcji Spółki, stanowiących 5.12% kapitału zakładowego Spółki, uprawniających do 1 087 615 głosów, które stanowią 5.12% ogólnej liczby głosów na walnym zgromadzeniu Spółki.

Przed ww. zmianą Fundusze posiadały 1 048 071 sztuk akcji Spółki, stanowiących 4.94% kapitału zakładowego Spółki i uprawniających do 1 048 071 głosów, co stanowiło 4.94% ogólnej liczby głosów na walnym zgromadzeniu Spółki.
